What is the purpose of this scholarship?

The purpose of this scholarship is to provide financial assistance to a high school graduate who desires to further their education at an institute of higher learning.

Who is eligible to apply for this scholarship?

Children and grandchildren of current Chi Epsilon Sigma members who have graduated from high school and are enrolled in a minimum of 6 hours per semester.

When should you apply for this scholarship?

Applications can be received now.

Upon what will the scholarship be based?

The scholarship will be based on a 500 word essay written by the applicant on why they would like to further their education. Grades, school/community activities, and special interest of the student may be listed in the essay but the scholarship will not be awarded based on these items.

Two \$250.00 scholarships will be awarded

Applications must be in hand by: September 10, 2010

After judging of essays, scholarship funding will be awarded to recipient after proof of enrollment is confirmed by the institution and approved by the scholarship committee.


